News from Kakinada, India.

Education Program – Sarada Vidyalayam

The school, Sarada Vidyalayam, was reopened in June after summer holidays. The eight grade seven students from last year passed the entrance examination in first class and enrolled in grade eight in prestigious high schools. This year, 23 new students were admitted into grade one. There are 17 students in grade two, 13 in grade three, 13 in grade four, 14 in grade five, 12 in grade six, and 13 in grade seven, for a total of 105, girls 55 and boys 50.

We are continuing to mentor and monitor those who have moved from Sarada into high schools and this year for the first time into junior colleges. There are eight in grade eight, 10 in grade nine, 15 in grade 10, and 11 in the first year under graduate level.

As in the past, education will be completely free for those enrolled at Sarada and for those who have moved on to high schools and colleges, support will be made available as much as possible on the basis of need.

Eye Care Program Srikiran Institute of Ophthalmology

Dr. M. Avinash, M.D., F.R.C.S., trained in the very prestigious All India Institute of Medical Sciences, New Delhi, has joined as a consultant.

The CIDA-Help the Aged Canada, project: Progressive Elimination of Avoidable Blindness due to Cataract and Glaucoma will be completed and reported by December 2003. A follow-up project: Blindness Prevention Program – Sustainability, was launched in April 2003.

The CIDA-MSMF project: Childhood Blindness Prevention Program is making excellent progress.

The construction of the new building for the Institute is behind schedule but it will be ready by December 2003.

Dr. Otis Paul, Pediatric Ophthalmologist from San Francisco, California, visited Srikiran from May 19 – 24. Dr. Paul participated in the

Hospital Based Program for training Pediatric Ophthalmologists at Srikiran sponsored by ORBIS International. At the same time, Dr. G.V. Rao and Dr. Preeti Singh from ORBIS India office also visited Srikiran. We are looking forward to joint projects with ORBIS.

Mr. Srinivas (Naren) Sankranti has joined Srikiran as Financial & Personnel Administrator in May. Naren worked for three years at MVP Foundation, a popular NGO in Hyderabad, India, dealing with eradication of child labour and rehabilitation of children through education. Earlier, he was an Officer at the Punjab National Bank for 20 years. Naren will be an asset to the growth and development at Srikiran. His wife Lakshmi is lending a helping hand with teaching at Sarada Vidyalayam and with management of the campus canteen.

Ms. Darlene Bhavnani, a microbiology graduate from Montreal, Canada, is a CIDA – Help the Aged Canada youth intern. She is at Srikiran on a six-month term to set up a microbiology laboratory for monitoring and identification of bacterial cultures and to provide training to Srikiran technicians.

Dr. Madhavi, a Senior Consultant from Srikiran, was invited to present her Manual Small Incision Cataract Surgery technique at a conference on Small Incision Cataract Surgery at Mumbai in August 2003. In November she is attending the American Academy of Ophthalmologists in Anaheim, California, and at that time she is planning to visit us in Canada.
